Of particular note will be a rare opportunity to encounter the work of acclaimed New York artist **Daniel Brush**. Brush's oeuvre—housed in institutions including The Metropolitan Museum of Art, The Smithsonian Institution, and the Victoria & Albert Museum—reflects a lifelong devotion to material, process, and scholarship. His extraordinary mastery of gold, steel, and unconventional materials, combined with an erudite, almost monastic approach, has produced works of breathtaking refinement and profundity.

Brush's creations, often described as “visual poems,” reveal both his technical virtuosity and his deep engagement with history, philosophy, and ritual. 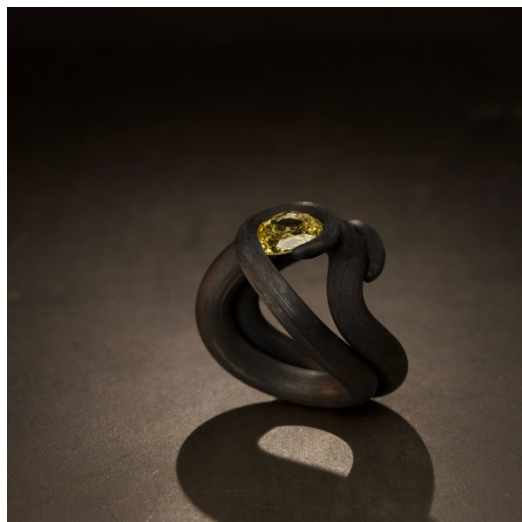
